WP1: Literacy Explanation

Description

You have just finished writing your Literacy Narrative. For this writing project, you will now explain the things that were confusing to you about that literacy context to a new user of the space. What language, symbols, and other ways of making meaning does a new user need to know? You will create your explanation in a form that's helpful for that new user, such as a video, a podcast, a website, a comic, or some other form of media. Your choice of media should make sense for the types of meaning you need to explain. Then, you'll write a short reflection explaining how you chose what literacy practices to adapt and how your adaptation fits your audience. In other words, how does it help them learn to use the space?

Learning Outcomes

By the end of this writing project, students will be able to:

- Recognize established genres and work toward replicating them.
- Adapt material to meet the needs of a specific audience and rhetorical situation.
- Employ strategies for revising texts.
- Reflect on rhetorical choices made when adapting their writing.

Requirements

Literacy Explanation

All drafts of the explanation of the literacy practices for a new user should include *roughly* **the equivalent content to 800 words of** text. Not all of the communication will be in word format, however, and may include images, video, sounds, symbols, or other media. All projects must include at least one other mode besides written text.

Reflection	A reflection is required as part of your writing project. The reflection must be at least 800 words .	
Submission	Please submit your reflection through OneDrive. If you have posted your Literacy Explanation publicly, you can place a link to it in your reflection document. If not, you can share your Literacy Explanation document in OneDrive as a separate file. Please approve any alternative methods to submit your Literacy Explanation with me in advance.	
Naming Documents	Please name your files using the following convention: course.section_your name_assignment.draft. For example, a student in ENGL 103 section 08 named Malcolm Reynolds working on WP1 draft 1 would name their file: 103.08_MalcolmReynolds_wp1.1

Completion Drafts	Completion drafts are graded simply on demonstrating a basic understanding of the requirements. Grades for completion drafts aren't an indication of how well you'll do on the revision draft. To get full credit for the completion draft, you must do the following:	
Choose a genre and format You have chosen a genre for your Literacy Explanation that the world and fits the literacy practices you're explaining. The not written text alone.		
Include specific literacy practices	You have explained several literacy practices that a new user might need to know. These are drawn from your narrative or your past experience. You explain them for the new user.	
Write a reflection	You have included a reflection the explains your choice of genre and format for the Literacy Explanation as well as any choices you made to help your audience understand.	
Adapt to your audience	In your reflection, you have considered who your audience is and what they need to know in your explanations. You have attempted to adapt to your audience's expectations.	

Revision Drafts

Revision drafts are graded on the criteria below. Each criterion is evaluated as "exceptional," "met," or "not met." If all of the criteria are "exceptional," you will earn an A. If they are all "met," you will earn a C. One or more criteria in the "not met" column will result in failure of the assignment.
